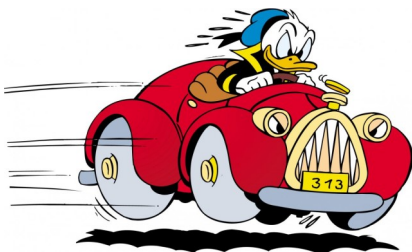

Updates:

- Any damage to grass due to snow removal will be taken care of by snow maintenance Company - Coming Soon.
- It is important to remind visitors to your home, **"No Street Parking"**. Please let them know to park in your driveway or the Guest Parking areas. Thanks! Also, if you have vendors doing work for you at r in your home they need to use "Guest" parking or your driveway. No extended parking on curbs or sidewalks.
- Each Board member has available for you: **"Guest Parking" passes**. Please contact any Board member to request one if you have a need. Please see Section VI #12 which reads: " A Temporary Parking Pass must be obtained for any guest whose visit is expected to exceed a two-night stay. Please plan in advance and, prior to your guest's visit, obtain a timed and dated Temporary Parking Pass from the Association. This procedure will help to identify and accommodate these vehicles that are welcome and authorized to park overnight in our common parking areas."
