# Reminder of Pool & Hot Tub Rules

- No lifeguard on duty. Swimming is at your own risk and diving is prohibited.
- No Children under the age of 18 are allowed at the pool without an <u>adult resident</u> present at all times and <u>All Guests</u> need to be accompanied by Adult resident.
- Hot tub is for use by those <u>14 years</u> of age & older. This is a SL County Ordinance!
- For safety and security, especially for children, be sure to close the gate securely when entering or leaving the pool. This also secures against unauthorized use.
- No food, glass or pets in the pool deck area.
